Awareness of importance and benefits of establishing good corporate governance is essential side by side issuance of laws and making their compliance mandatory in order to establish, or enhance the practice of, good corporate governance in corporate entities. In addition to that knowledge about religious guidance with respect to establishing good corporate governance may become supplementary to willful compliance with the mandatory provisions. As such, having discussion on Guidance of Islam regarding good corporate governance is a demand of the time.
